Rules and Regulations

- 1. Participants will keep to the left side of the road and not violet any other traffic rules.
- 2. Participants will maintain a maximum cruising speed of 30 kms /hr.
- 3. No overtaking will be allowed.
- 4. A pilot car/bike or Traffic police will lead the rally along the entire route.
- 5. A tow vehicle will be arrange to deal with any vehicular breakdown
- 6. The rally will adhere to the time schedule as per plan
- 7. All the drivers will carry their valid and current vehicle registration papers, insurance documents, Puc certificate and driving license with them.
- 8. Participants will not cause any with full constructions to the smooth flow of traffic.
- 9. Each participant is eligible for lunch coupons. 2 for car and 1 for bike
- 10. Bikes shall be permitted with rider plus one pillion. Helmet is compulsory for the rider. However only one lunch coupon is provided for 2 wheeler.
- 11. The Organiser many screen all the vehicles participants are requested to ensure that their vehicle looks good and are in working order.
- 12. Participation without registration will not be allowed.
- 13. Participation in the Goa tourism bike and car festival 2016 shall be the soul responsibility of the vehicle owner. The principle and management of Gtdc, ESG and the sponsor are not responsible for any way for breakdown or damage to participating vehicle/displayed vehicle. Parking is at owners risk solely.
- 14. Vehicle owners will be liable for any damage to other participants vehicles or spectators caused due to negligence of the owner driver or driver.
- 15. Vehicle will be flagged off as per the serial no. allotted. Participating vehicles must parade drive in the same order.
- 16. All participating vehicle must maintain 25 feet gap as breaking distance between each vehicle.
- 17. Upon breakdown of your vehicle move left and signal for the following vehicle to pass. Inform the organizers thereafter. Kindly ensure that you park your vehicle at the left and wait for the tow arrangement.
- 18. Judging of vehicles will be done by professional judges and their decision will be final
- 19. All participating vehicles are obligated to remain on display between 9:30 am to 5:30 pm on 1st Oct 2016 .
- 20. The organizers decline liability of any and or omission resulting in any loss, injury or accident caused by or to participants and the participating cars and two wheelers or the persons or the property or a third party before, during or after the event. The sponsors organizers, Gtdc also decline any liability for breach of laws and regulations of India. Participants will be held entirely responsible for any accident or breach of laws in which they may be involve and shall declare to organizers particulars of any accident from which liability may arise and shall indemnity the sponsors, the organizers, the GTdc in regard to any liability. A participant, driver, enfant participants, crew members, agents shall have no claim against the sponsors, the organizers, GTDC arising out of any action of the organizers their servants or agents or officials during the rally.
- 21. The organizers may add their discretions, abundant, cancel or postponed the meet in case of unforeseen circumstances.
- 22. The organizers and or the clerk of the course reserve the right to delete and or change any part of the route should they deem it necessary or expedient at any time or due to force majeure or for any other reason.
- 23. The interpretation of this rules and regulations and decisions regarding and unforeseen circumstances shall rest with the organizers.
- 24. All the discretion to accept the vehicle will be governed by GTDC. The decision of GTDC will be final and binding.
